Hi Richard

Apologies for the email out of the blue, but may I propose an agenda item for the July LGNYY meeting?

As you know, and as Julia and you may have discussed before, CCTV funding is a growing concern across the city and county. Some local authorities are affected more than others. Given this burning platform, as well as a police review of counter-terrorism and a deluge of national programmes coming from the Home Office and MoJ, it has been a good time to bring all partners (including the MoD, BIDs and charities) who are involved in CCTV together to discuss the future. Cutting a long story short, we made some progress with trying to reorganise CCTV provision but got a bit stuck given the patchwork approach and varying levels of investment. To try to progress further, Julia has funded an independent CCTV expert to come and speak to all parties, assess where we are and propose sustainable and future-proof structures. We have no idea what those suggestions will be yet, but I suspect it will be about one shared infrastructure, jointly funded by all parties, and a more centralised monitoring hub rather than the six or so hubs we have at the moment across North Yorkshire(and the inherent cost in duplication etc.).

Whilst those at officer level have been engaged in this process from the outset, there comes a time where self-interest cannot be avoided. In that regard, once the independent assessment is complete, I hoped to be able to bring it to the LGNYY so all local authorities know exactly what could be achieved if we work together. I firmly believe there is the potential here to both save serious sums of money and improve community safety. This will only be the case though if local authorities all pull together.

I am happy to explain the process further, but July would be a good point to present the findings to leaders and CEOs, and get sign-off on the various models this review may throw up. We will need a decision from each local authority at some point, and a joint discussion would be extremely helpful indeed for all concerned.
